Funds for institutional **merit** scholarships and **Loyola Grant** programs are generally earmarked for use during the academic year. **No funds will be awarded for the 2011 summer semester.**

Eligibility for federal loans is limited to the difference between the amount borrowed during the previous Fall/ Spring semesters and the maximum loan limits for each specific grade level as set by the U.S. Department of Education.

**NOTE:** You must be registered for **and maintain** at least 6 hours (undergraduate) or 5 hours (graduate) before we can award you summer financial assistance, and to remain eligible for it. An exception to the half time enrollment rule may apply to Pell Grant recipients.

The following websites contain information on other alternatives for financing that can be used to supplement your financial aid award. Please be aware that if the parent of a dependent student applies for a federal Plus loan and it is denied we can offer the student an additional Unsubsidized Stafford loan, which must be requested by the student in writing. The maximum loan limits for each specific grade level are set by the U.S. Department of Education.

If your loans cover your charges, the Student Finance Office will not charge you late fees.

All **first-time** Federal Direct Student Loan borrowers at Loyola must participate in loan entrance counseling, even if you have borrowed at a previous institution.
